 - c) Statement of Marks and degree certificate of Graduation, Post-Graduation and M.Phil (if applicable).
 - d) Caste Certificate, Caste Validity Certificate and Non-Creamy Layer Certificate if applicable);
 (Valid till 31-03-2025).
- 3. Candidates should report 30 minutes before the interview along with all the original documents and certificates for verification.
- 4. Selection and allotment of Guide will be done as per University Norms/Guidelines.

Instructions to the candidates for Personal Interview for Ph.D. Admission 2024-25

The University through this notification hereby issues following directions for the information and compliance by all eligible candidates for Personal interview. (Qualified in Entrance Examination/ Candidates exempted from Entrance Examination for Ph.D. Admission 2024-25).

As per provision of University Circular No. 152/2024 dated 09/07/2024, personal interviews shall be completed before 31/01/2025 for Ph.D. admission. Detail scheduled will be declared by all respective University Departments/Research Centres on their website/communicated through email to candidates.

Instructions to the Candidates appearing for the interview:

- Eligible candidates are required to discuss their research interest/area before a duly constituted Selection Committee.
- > The following aspects shall be considered during the interview, namely:
 - a) Whether the candidate possesses the competence for the proposed research;
 - b) Whether the research work can be suitably undertaken at the Institution/College;
 - c) Whether the proposed area of research can contribute to new/additional knowledge
- The candidate shall produce all the required documents in ORIGINAL along with one set of photocopy, including online application for Ph.D. PET Entrance Examination 2024, at the time of personal interview. Further, following documents, as applicable for exemption of PET should be produced:
 - a) Result of PET Entrance Examination 2024.

or

Photo copy of UGC-NET (Including JRF) / UGC-CSIR NET (Including JRF) /SET / GATE (valid score), GPAT (valid score) Certificate and other similar Certificates for exemption as notified in the notification.

- b) Marks Statement of Post Graduation.
- ➤ In addition to above candidates belonging to reservation category shall produce following documents in original along with one set of photocopy.
 - a) Caste Certificate
 - b) Non Creamy Layer for other than SC, ST & EWS.
 - c) EWS Certificate for EWS
 - d) UDID Certificate along other necessary documents for Divyang Student.
- > The candidates shall note the following:
 - a) They shall report at the centre One hour before scheduled time.
 - b) They have to appear before the panel on scheduled day and time only. In any circumstances, the late comers will not be allowed and there will not be any "out of turn" chance given to the late comers.
 - c) Candidates can appear for interview only at the chosen research centre.
 - d) TA/DA will not be provided to the candidates for attending the interview.

All other directions of the above-referred notification remain unchanged."
